

3-STEPS TO SASI ACCREDITATION

Step 1: Explore



"Test-drive" accreditation with expert guidance and identify quality gaps Step 2: Improve



Take the "SASI Pledge" and increase Site income while you prepare for accreditation Step 3: Get Accredited



Request the official conformity assessment and complete the accreditation

STEP 1: Test-Drive the Road to Accreditation with the SASI QM Framework Program

- An engaged, educational, online, and manageable process with a SASI liaison
- Expert instruction on the SASI Standard and its Accreditation Protocol
- Guided site-scoping and gap analysis to map your Site's path to accreditation
- Emphasis on site growth, marketing, leadership development, and profitability
- Self-paced online study to certify two Clinical Research Quality Managers (CRQM) to manage the task of building a profitable, accreditable, culture¹

\$5495 Per Site. (Less than the costs associated with attending one conference with tuitions and travel expenses.) The purpose of the QMFP is to learn about the SASI Standard, experience and evaluate the requirements and benefits of accreditation, identify the Site strengths and gaps; equip two leaders to forge the way, and then create a profitable plan to pursue and achieve accreditation.

STEP 2: Take the "SASI Pledge" to Improve, Increase Income, and Prepare for Accreditation

STEP 3: Set a Course to the SASI North Star. Grow Your Business and Get Accredited

- When ready, the CRS staff will submit the documents demonstrating conformance to the Standard via the Accreditation Management Directory.
- SASI Surveyors and CRS leaders will collaboratively review nonconformances that must be addressed to achieve SASI Accreditation.
- After the SASI Surveyors have confirmed conformance to the Standard, and a site visit is successfully completed, the Surveyors will submit their report to the SASI Accreditation Council for review and approval.
- Following approval, the site's SASI Pledge Page will be updated from "Candidate" to "Accredited" with a unique serial number; and the "SASI Accredited" icon can be added to your website.
