TERMS OF USE POLICY

BY ACCESSING OR USING ANY OF THE SASI SITES OR THE SERVICES, YOU ARE ENTERING INTO A LEGAL CONTRACT WITH SASI, THE TERMS OF WHICH GOVERN YOUR USE OF THE SITES. ACCORDINGLY, BY YOUR ACCESS OR USE YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS DESCRIBED HEREIN AND ALL ADDITIONAL TERMS INCORPORATED BY REFERENCE. IF YOU DO NOT AGREE TO ALL OF THESE TERMS, DO NOT USE THE SASI SITES OR SERVICES.

These web site Terms and Conditions ("Terms of Use") apply to your access to, and use of, SASI's web sites as well as any other SASI-allied or controlled sites or affiliates sites, regardless of domain name or IP address (collectively "Site" or "Sites") and features and applications accessible through, or in connection with, the Sites (collectively the "Services"). Further, these Terms of Use are in addition to the terms or conditions of any other agreement you may have with SASI, or its affiliates, for products, services or otherwise, including, without limitation, terms, conditions, and policies relating to the accreditation services, courses, and educational programs provided by SASI. The SASI Sites are made available by the Site Accreditation and Standards Institute ("SASI" or "we" or "us").

We may change these Terms of Use from time to time, by posting such changes on the SASI Sites, and such changes will be effective upon any further use of the SASI Sites. BY USING THE SASI SITES, YOU ACCEPT AND AGREE TO BE BOUND BY THESE TERMS OF USE AS APPLIED TO YOUR USE OF THE SASI SITES. IF YOU DO NOT AGREE TO THESE TERMS OF USE, PLEASE DO NOT ACCESS, OR OTHERWISE USE THE SASI SITES.

1. Proprietary Rights

As between you and SASI, and except for your Submitted Materials (as defined in Section 5 below), SASI owns, solely and exclusively, all rights, title and interest in and to the Sites, all the content (including, but not limited to, all audio, photographs, images, illustrations, renderings, drawings, Webcasts, RSS feeds, podcasts, other services, graphics, logos, scoring information, games, widgets, gadgets, applets, other distributable applications, handicapping materials, other visuals, video, copy and software), software, code, data and other materials thereon (collectively, the "Site Content"), the look and feel, design and organization of the SASI Sites, and the compilation of the Site Content, including but not limited to any copyrights, trademark

rights, patent rights and other intellectual property and proprietary rights therein. Your use of the SASI Sites does not grant to you ownership or title of, in or to any Site Content or any other part of the SASI Sites.

2. Limited License

Subject to the terms and conditions set forth herein, SASI grants you a non-exclusive, non-transferable, limited license to access, view, use and display the SASI Sites and Site Content and on your computer or other Internet-capable device, provided that you comply fully with these Terms of Use. The SASI Sites and Site Content are for your personal, educational, and noncommercial use only. Any commercial use, distribution, publishing, or exploitation of the SASI Sites, or any Site Content, is not allowed unless you have received the express prior written permission of the SASI or the applicable rights holder.

3. Trademarks

The trademarks, logos, service marks and trade names that may be displayed on the SASI Sites or on-Site Content are registered and unregistered trademarks of SASI and other persons (collectively, the "Trademarks"), and may not be used unless authorized by the Trademark owner. Nothing contained on the SASI Sites should be construed as granting, by implication, estoppel, or otherwise, any license or right to use any Trademark displayed on the SASI Sites without SASI's written permission or that of the third-party rights holder.

4. User Accounts

To access, browse and use certain services or features, or to submit content, information, materials or participate in certain activities, on the SASI Sites, you may need to create an account on the SASI Sites and submit certain personal information. Unless specifically requested, SASI does not solicit, nor does it wish to receive, any confidential, secret, or proprietary information or other material from you through the SASI Sites, by e-mail or in any other way. Any information, proposals, requests, creative works, pictures, photographs, documents, letters, demos, ideas, suggestions, concepts, methods, systems, designs, drawings, renderings, plans, techniques or other materials submitted, posted, uploaded or sent or transmitted on or through the SASI Sites in any manner (collectively, "Submitted Materials") will be deemed not to be confidential or secret, and may be used by SASI in any manner consistent with these Terms of Use and the SASI Sites' Privacy Policy.

By submitting, uploading, posting or sending Submitted Materials to or on the SASI Sites, you: (i) represent and warrant that either (A) your Submitted Materials are original to you and that no other party has any rights thereto or (B) that you have the necessary licenses, rights, consents and permissions to use such Submitted Materials and submit them to the SASI Sites for the SASI's use in accordance with these Terms of Use and the purposes described on the SASI Sites, and that any "moral rights" in the Submitted Materials have been waived; and (ii) you grant to the SASI (and its affiliates) a royalty-free, unrestricted, worldwide, perpetual, irrevocable, non-exclusive and fully transferable, assignable and sublicensable right and license to use, copy, reproduce, modify, adapt, publish, translate, create derivative works from, distribute, perform, display, make, sell and export such material (in whole or part) and/or to incorporate it (in whole or in part) in other works (including, without limitation, the SASI Sites), products or services in any form, media, or technology now known or later developed. You agree to defend, indemnify, and hold SASI and its and their directors, officers, employees and agents harmless from any and all claims, liabilities, costs and expenses, including reasonable attorneys' fees, arising in any way from (i) your use of the SASI Sites or the Site Content, (ii) your Submitted Materials, in whole or in part, or (iii) your breach or violation of the law or these Terms of Use. 10. Orders for Products and Services

We may make certain products and services available for purchase or download to users of the SASI Sites. 11. Cancellations, and Refunds

Cancellations and refunds are subject to a three-tiered policy.

Fourteen Day Cancellation and Refund Policy:
 If the original purchaser cancels or requests a refund within fourteen (14) days of enrollment and contacts SASI in writing at admin@sasi-accreditation.org to request a refund; the original payment will be refunded (less credit card processor fees not to exceed five percent (5%) of the total purchase) using the method of payment to refund that was originally used to transmit payment to SASI.

Credit card processing fees are refunded to SASI at the sole discretion of the Bank or credit card processor and this refund policy may be modified based upon the individual facts and circumstances of each transaction. SASI will take reasonable steps to secure a full refund of the Purchaser's payment. However,

SASI will retain the right to withhold from the Purchaser's refund any portion of the Credit Card Processing charges retained by the Credit Card Processor (not to exceed five percent (5%) of the total purchase).

- Greater than fourteen (14) Days and Less than thirty (30) Days Cancellation Policy: All cancellation requests after fourteen (14) days and within the first thirty (30) days of initial enrollment must be submitted in writing to admin@sasi-accreditation.org. The request should include a detailed explanation of why the original purchaser cannot continue in the course, training, or service. Any cancellation requests approved after fourteen (14) days and within thirty (30) days of enrollment will be in the form of a "transfer credit." A "transfer credit" enables the original Purchaser to elect to transfer your rights and privileges (course and website access relative to the tuition) to another person of your choice.
- Thirty (30) Days or Greater Cancellation Policy: Thirty (30) days or greater from the initial enrollment, all course and services fees are non-refundable and non-transferable.

1. Summary

The Site Accreditation and Standards Institute ("SASI," "we" or "us") operates the sasi-accreditation.org website (the "Site"), which is hosted in the United States. We want you, our visitors, and members, to understand how we collect and use data about your Site visit. The privacy policy below identifies what information the Site collects, and what it is used for. We use cookies, which gather certain forms of information from your computer to help us monitor and improve Site usage and performance. Certain web pages may allow you to voluntarily submit personal information about yourself. This may include your name, address, email address, telephone or fax number, any content you post, and certain other information, which we explain in more detail below. You can choose not to provide us with this information, but certain portions of the Site may not be available to you.

We do not disclose this information to third parties for their marketing purposes without your prior consent, but we do use third party software and services to assist us with collecting and analyzing information regarding use of the Site. We may also disclose your information to others for other purposes, particularly if required to do so by law. The privacy policy for the Site is set forth below and you should contact admin@sasi-accreditation.org if you have questions or concerns about this policy or the use of your information.

2. Information Collection

This is our online privacy policy ("Web Privacy Policy"). This Web Privacy Policy applies only to activities we engage in on the Site and does not apply to activities that are "offline" or unrelated to the Site.

Anonymous Information. We may collect two types of information through this Site: anonymous information and personally identifiable information ("PII"). We collect certain anonymous data regarding the usage of the website. This information does not personally identify users, by itself or in combination with other information. We gather it to improve the performance of the Site. The anonymous data we collect can include information such as the type of browser you are using, IP address, the pages you view, and the length of your visit to the Site.

Personally Identifiable Information. We may also ask you to provide personally identifiable information on the Site, which may include your name, address, telephone number, fax number, company name, e-mail address and relevant details about your expertise and interests. This information can be gathered when you send us an e-mail, when you complete the specific web page request form, or as you complete or modify your personal profile. Surveys. We may occasionally request information from you via surveys. Your participation in these surveys is completely voluntary. The information that we request typically includes your contact details. If you choose to participate, the information that you provide may be shared with the survey sponsors. Survey information may also be used to monitor and improve the content and performance of the Site.

3. Cookies and Web Beacons

Cookies are small bits of data cached or stored on your computer based on Internet activity. We use cookies to monitor individual activity in aggregate to improve the Site. The information we gather may include IP address, user language, the operating system, browser type, the presence/absence of "flash" plug-ins, screen resolution, connection type, and information that identifies the cookie. However, no other user information is generally collected. On most web browsers, you will find a "help" section on the toolbar. This will tell you how to stop accepting cookies, how to be notified when you receive a browser cookie, and how to disable existing browser cookies. Remember though that without browser cookies you may not be able to take advantage of all our Site features.

We also use web beacons (also known as clear gifs), which are tiny graphics embedded on a web page to help us measure the effectiveness of particular content. Unlike cookies, web beacons are not stored on your computer's hard drive.

4. Use and Disclosure Information

Uses by SASI. SASI uses the personal information you provide through the Site in a manner that is consistent with this Web Privacy Policy. If you provide personal information for a certain reason, we may use it in connection with the reason for which it was provided. For instance, if you contact us by email, we may use the personal information you provide to answer your question or resolve your problem. We use the information collected through the Site for statistical purposes and for improving the Site, as well as for our marketing purposes and potentially sending commercial emails to you. We often engage a third party's software or services to assist us with these collections and analyses. As a practical matter, we must release your mailing address to a postal or courier service to deliver information you requested. We use third parties to assist us with our marketing efforts, including assisting us with sending emails to you. This may include sending you free electronic newsletters and marketing-related emails for services described on our Site. However, you will have the choice to opt out of receiving newsletters and marketing emails for our services by either contacting us directly at admin@sasi-accreditation.org or the "unsubscribe" link found at the bottom of our newsletters and emails.

In addition to using your information to populate your My Registration Account pages, SASI and our agents will use your personal information to process purchase orders that you submit via the Site and enable you to track the progress of purchase orders. This may include sharing certain data with delivery providers such as UPS and providing you access to shipper tracking numbers. Similarly, if you qualify for any rewards or discounts based on your purchase history,

this information too will be processed by us and our agents to enable your access to these benefits.

On certain of our Site pages where you have submitted detailed information concerning potential products or services, we will use this information only for the purposes of contacting you and determining which product or services may be most relevant to you. We will not share this information with any third party for their own marketing purposes without your prior consent. We may also disclose personally identifiable information in order to respond to a subpoena, court order or other such request. We may also provide such personally identifiable information in response to a law enforcement agency's request or as otherwise required by law.

We may provide your personally identifiable information to a third party if we file for bankruptcy, or there is a transfer of the assets or ownership in connection with proposed or consummated corporate reorganizations, such as mergers, acquisitions, or sales of business units. Uses by Third-Parties. We do not provide your personally identifiable information to any third party for their own marketing purposes without your prior request or consent. We work closely with certain organizations to provide you with products and services. Sometimes these organizations make special offers available to our members. If you request to receive information about these offers, we will share your personal information with these organizations so that they can send you details about their special offers. You should know in advance that each of these organizations has its own policies with respect to the collection and use of personal information and that we are not responsible for their use of your information.

5. Information Security and Secure Transactions

We have implemented various security measures for the purpose of protecting your personal information against accidental or unlawful destruction or accidental loss, alteration, unauthorized disclosure or access and against any other unlawful forms of processing. When you create a user profile and log in to a secure portion of our Site, your personal information benefits from the protections of Secure Sockets Layer ("SSL") technology. Our web servers have been enabled with SSL technology to automatically encrypt your information and help prevent unauthorized parties from viewing your account or payment information during a secure session. This is why you must enter your unique username and password each time you access your account information online or place a purchase order through the Site.

You are responsible for maintaining the confidentiality of your username and password. You are responsible for all uses of your password, whether or not authorized by you. You must inform us immediately of any unauthorized use or your username or password. However, the transmission of data over the Internet by its nature entails the use of systems under the control of third parties, and as a result we will work to prevent any violation of the

security systems but cannot ensure a total control of the security of such systems.

6. Other Websites

Please be aware that our Site may contain links to other sites on the Internet that are owned and operated by third parties. The information practices of those websites linked to our Site are not covered by this Policy. We are not responsible for the privacy policies of websites to which the Site links. If you provide any information to such third parties, different rules regarding the collection and use of your PII may apply. We strongly suggest you review such third party's

privacy policies before providing any data to them. These other sites may send their own cookies or web beacons to users, collect data or solicit personally identifiable information. We cannot control this collection of information. You should contact these entities directly if you have any questions about their use of the information that they collect.

7. Children

SASI understands the importance of protecting children's privacy in the interactive online world. The Site covered by this policy is not designed for or intentionally targeted at children 13 years of age or younger. It is not our policy to intentionally collect or maintain information about anyone under the age of 13.

8. Inquiries, Corrections and Complaints

Your data is submitted to SASI and is hosted and stored in a database on servers situated in the United States by us and by third parties on our behalf. If you are located outside the United States, your use of the Site constitutes your consent to the transfer of any personal information to the US.

You are responsible for ensuring that the personal information you have submitted or access through the Site is accurate and complete. You may change the information we have on file for you by accessing My Registration Account and entering any new or different details. If you have included payment details or credit card information, you may alter these via the appropriate link on your My Account page. Please contact us immediately if you notice changes to your profile that you did not request or if you notice any suspicious activity concerning your account.
